• Second Wind – A quote from Second Wind to re-bed the lead carbon tank was reviewed and signed. This is for 45 Durgin Rd., discussion followed. This landfill closure is 30 years old, it is nearing the end of the closure cycle. Selectman Parisi recused himself from signing this quote, siting a conflict of interest due to his profession. Selectman McClure and Chairman Cleary signed the quote.

- Library Trustee Appointment D. McKenzie, R. Davie were approved, Town Clerk, Deb Belcher will be provided the information.
- **Highway Department** Selectmen discussed the backhoe, summer projects, vehicle maintenance and more. Selectmen would like Road Agent, DJ Wing to come to the next meeting for a monthly update, further asking that he have a schedule for his plans for the next two months prepared, as well as being prepared to discuss winter maintenance, vehicle maintenance on Fire, Police and Highway equipment.
- Police Schedule Selectmen reviewed a schedule that was provided by Chief
   Sullivan
- Minahan Jackets Discussion followed asking if Selectmen would support Ms. Minahan purchasing her jackets the Town purchased for her. Selectmen were not supportive of this.
- Trees at Sawyer Field Don Trow will start taking down some trees at Sawyer Field next week. Selectmen have gone over what is expected with Mr. Trow, he is aware of the goal and will keep in mind the removal of trees is for additional parking. Removal of the stumps was discussed, this will be discussed with DJ, the use of a ripper will make pulling the stumps much easier.
